July will be the first outcomes report. COHORT 29 is in the 3<sup>rd</sup> quarter of its second year. Outcome reports in October. Some may have to utilize a revision process. Also have been working on policy requirements from the grantees.

Karen Shanoski from CSC discussed the renewal process for COHORT 30. Some of COHORT 30 is struggling to start and get established. Learning Lamp had hiring struggles but has since hired the staff needed.

#### **Public Board Members**

Public Board Member and Chair Bruce Clash discussed public board member nominations. First time in 7 years. Public Board Member and Co-Chair Angela Liddle provided an update on the 4 new members being signed off and moving through the process. Their first meeting pending all approvals will be In August. The Governor's office intends to make additional public member nominations throughout the next state fiscal year.

No actions were taken.

#### Request for Application Cohort 31

Andrew Dietz, OCDEL, provided an update on the Request for Application for COHORT 31. The release of the RFA was pending one final review.

Public Board Member and Chair Bruce Clash discussed the calendar year RFA option. Andrew Dietz, OCDEL explained availability and timelines of staff and other DHS offices. Rijelle Kraft, CSC spoke about the COHORTs coming up may only have 4 or 5 eligible LIAs.

An option was presented to delay until the spring for a larger RFA with more LIAs eligible or to continue with the current release. Public Board Member and Co-Chair Angela Liddle offered support for either decision to rush or postpone. Public Board Member and Chair Bruce also supported either decision.

Rijelle Kraft, CSC stated legal and the timeframe of when they return information is a big factor. Also mentioned stress on applicants and none of the existing grantees would be eligible.

The board deferred to OCDEL and CSC to determine if the RFA should be released as scheduled. The RFA was released on June 28<sup>th</sup>, 2023 - http://www.emarketplace.state.pa.us/Solicitations.aspx?SID=RFA%2013-23

#### National CTF Alliance Representation

Public Board Member and Co-Chair Angela Liddle explained structure of the National Alliance and appointed member process. Angela Liddle requested permission from this board via a majority vote to finish her term on the national alliance board. Angela's term on the national alliance board Concludes Dec 21, 2024.

Angela Liddle summarized a description of her responsibilities on the board. Such as serving as secretary and the non-profit voice on the board. Plans to communicate information from the board to Andrew, Karen, and Rijelle to keep information flowing to this board.

Public Board Member and Chair Bruce Clash commended Angela's time on the Alliance and proposed to extend her position on that board until the end of her term via vote. Jessica Sander representing Rep. Donna Bullock seconded. Motion was passed by the board unanimously.

## Workgroup for CTF Statue Updates

Public Board Member and Chair Bruce Clash spoke about the informal work group for the CTF Statute updates. Terminology and references to abuse needed updating.

# Act 112 of 2022 - PennDOT Donations

Public Board Member and Chair Bruce Clash provided background of the work to add donations to CTF through PennDOT.

These donations are expected to potential add up to \$150,000 to the CTF fund once implemented. Andrew Dietz, OCDEL provided an update that the donation option should go live on July 16, 2023.
