Pennsylvania Children's Trust Fund

The Pennsylvania Children's Trust Fund (CTF) was established in December 1988 by Act 1988-151 [11 P.S. §§ 2231-2238] and is supported by the Department of Human Services (DHS). CTF operates under the administration of the 15-member CTF Board, which is composed of legislators appointed by the House and Senate and citizens appointed by the Governor. The Deputy Secretary of DHS' Office of Child Development and Early Learning (OCDEL) serves as CTF's Executive Director and carries out the duties and responsibilities assigned by the Board through OCDEL's Bureau of Early Intervention Services and Family Supports.

Preventing Child Maltreatment

Child maltreatment continues to occur in Pennsylvania communities. Substantiated reports of child abuse decreased from 1.9 per 1,000 children in 2021 to 1.8 per 1,000 children in 2022.1 However, this is still up from 1.7 per 1,000 children reported in 2020.2 The CTF Board funds community-based programs through three-year grants to implement evidence-based programs and promising practices that are designed to promote child well-being and prevent child abuse and neglect. The funded programs support families to create safe and nurturing environments for their children. Grantees are asked to collaborate in their community, intentionally integrate the Strengthening Families™ Protective Factors (SFPF) Framework into the work, and create a plan to sustain their programs after CTF funds have expired.

Funds for CTF are generated from a surcharge on all applications for marriage licenses and divorce complaints, State Income Tax check-off option, and online vehicle registration and driver's license renewals that are paid into a special non-lapsing fund. Since its inception, CTF has invested more than \$42.7 million through 335 grants. Impact

Triple P has offered different groups throughout the county over the past year. Recently, we had several referrals through Probation that all came in around the same time. We were able to offer a lunchtime group to accommodate work hours. Four fathers enrolled in the Lunch and Learn Group. The dads were engaged and were able to learn from others' experiences. All four fathers attended and completed the program.

One of the best success stories is when a parent realizes that the PAT Program is really in place to help them, not just their children! "S" is just that parent. Activities we do at visits are done after visits and I get updates and sometimes photos. "S" also shares with me the new skills her children are doing, and she is now looking for progress and recognizing their growth. According to "S", she has followed through with several community resources provided which could result in some favorable changes for the children, including quality childcare enrollment and a job for "S". Although there have been several serious issues that have recently affected the family, "S" has not lost sight of the fact that her children are her #1 priority.

A mother in a Nurturing Parenting program discussed how she was raised in an abusive home and wants to stop that cycle of abuse. She wants to be the best parent she can be and learn how to do things differently.

A father in a Parents as Teachers Program noted how important it is for him and his child to attend Group Connections, so they are not isolated at home. The father mentioned how the Group Connections allow him the opportunity to talk to other parents about parenting and allow his child to interact with other children.

A participant in a Triple P Program explained that her parents used fear as a component when parenting her. She realized that she must start with how she thinks, consider how she was raised, and overcome that generational learning because that is not how she wants to parent her children.

Pennsylvania Strengthening Families Leadership Team

Pennsylvania Strengthening Families Leadership Team (SFLT) activities are supported by the CTF Board, which contracts with Center for Schools and Communities (CSC) to facilitate this work. CSC coordinated four SFLT meetings in 2022-2023, focused on effectively embedding the Strengthening Families™ approach in organizations and systems, promoting family engagement and leadership, and facilitating the strategic plan update. CSC served as the lead for Be Strong Parent Café expansion and support and led the transition from online Parent Cafés to place-based Parent Cafés.

SFLT works to promote the inclusion of the Protective Factors Framework into policies, programs, and practices in multiple family service systems throughout the state. The team consists of leaders in various systems and communities.

The Strengthening Families™ approach promotes the development of protective factors within families, building on strengths, rather than focusing on risks. It is not a curriculum or a program but a framework of five research-informed protective factors, identified by the Center for the Study of Social Policy, that support families so that even in stressful times child maltreatment may be prevented. It is based on the belief that all families have strengths and all families need support. When these protective factors are robust in families, children thrive.

Professional Learning Experiences

1,384 people participated in professional learning experiences in 2022-2023:

- 26 participants attended the Cohort 30 CTF Grantee Orientation.
- 37 participants attended the CTF Logic Model and Outcomes Reporting webinar.
- 530 participants attended six webinars focused on best practices in family support.
- **92** participants (representing 19 teams) attended four place-based Parent Café Training Institutes.
- 35 participants (representing nine teams) attended three virtual to place-based Parent Café Crossover courses.
- 45 Participants attended four Pennsylvania Parent Café Learning Communities.
- 25 participants attended two virtual Building
 Protective Factors through Parents Café workshops.
- 27 participants attended two virtual Hosting Meaningful Café Conversations workshops.
- **78** participants attended six Bringing the Protective Factors Framework to Life in Your Work courses.
- 97 participants attended three workshops focused on family engagement informed by the Strengthening Families Protective Factors Framework.
- **26** participants attended two Strengthening Families Overview workshops.
- 101 participants attended two Strengthening Families Protective Factors Orientation sessions.
- 265 participants attended the 2022 Strengthening Families Conference which was place-based and held in Harrisburg, Pennsylvania.
